## RICHARD AND JANICE HELGESON “Richard and Janice Helgeson Family Fund”

Richard (Dick) and Janice (Jan) Helgeson chose to create a fund with the Winneshiek County Community Foundation, an affiliate of the Community Foundation of Northeast Iowa to benefit the beautiful park system in Decorah. “By donating to the Foundation,” said Jan, “we can give back to our community and receive the 25% state tax benefits.”

When Jan Helgeson joined the Winneshiek County Community Foundation Governing Committee in September of 2004, she didn’t know that one day, her experience with the organization would lead she and her husband to establish a family endowment fund with the Foundation.

“I was fortunate to be on the Committee for over 5 years,” said Jan. “I have witnessed the wonderful nonprofit organizations that have benefitted from grant dollars.”

Both Dick and Jan grew up in Winneshiek County and attended the Decorah Schools first through twelfth grades. “We were both born and raised in Winneshiek County and are proud of the beauty of the area,” said Jan. “We want to help preserve, share and support the maintenance of our wonderful park system.”

For many years, Dick and Jan leased a piece of land to the city of Decorah at no cost, other than payment of the yearly real estate taxes. Dick and Jan sold the property to the city of Decorah in 2010 and established a fund with the Community Foundation to benefit the Decorah Parks.

Both Dick and Jan have served in the community for many years. Dick has been a volunteer fireman for 28 years. As a couple, Dick and Jan have given to the Winneshiek Medical Center, United Way, and Susan Komen Breast cancer fund. They have also attended many seminars on charitable giving.
