Added Benefits of Giving

Endow Iowa legislation makes donors to the fund eligible for a 25% state tax credit in addition to the normal federal deduction for charitable giving. To receive the tax credit, the fund must be endowed with a community foundation that meets National Standards, like the Community Foundation of Northeast Iowa.
